The management report should be around 10000 words covering the 400 levels Modules. International Accounting Company Law Quantitative Methods Business Ethics Financial Accounting, Analysis and Valuation Management Accounting Financial Management and Organizational Control or Auditing, Governance and Risk Management Corporate Finance, Investments and Financial Markets or Quantitative Finance C7- Project report. Students are required to complete a project about 15000 words in any area of their choice which form part of the specialization or Major. The Body of Knowledge could be in taxation, Accounting, financial management etc.
